## Partnership

### Ameren Illinois & Champaign County Regional Planning Commission (CCRPC)

- Market Development Initiative (MDI)
  - Engage customers who have not previously benefitted from energy efficiency
  - Increase number of energy efficiency jobs available to local and diverse candidates
  - Support new or growing energy efficiency businesses
- Partnership with CCRPC
  - Lead for MDI data planning and analysis

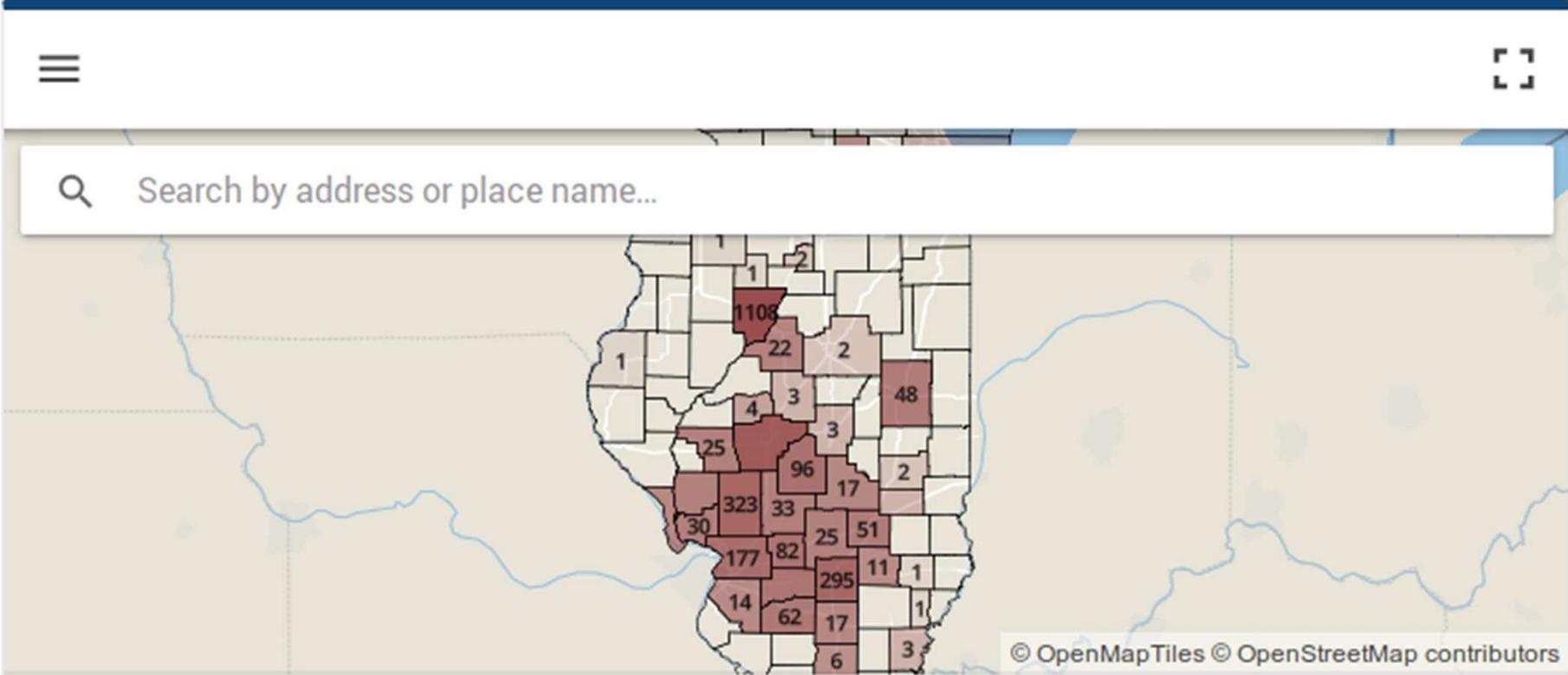

## Demographics Strategy

- Difficult to collect demographic data from participants
  - Partners are interacting with participants in many ways
  - Information about age, income, etc. is sensitive
- Participant addresses allow us to identify their neighborhoods
  - U.S. Census Bureau provides demographic data
  - These public data give us insight into the people living in that neighborhood
- Neighborhoods can be defined in different ways
  - Census tracts
  - Zip codes

## U.S. Census vs American Community Survey (ACS)

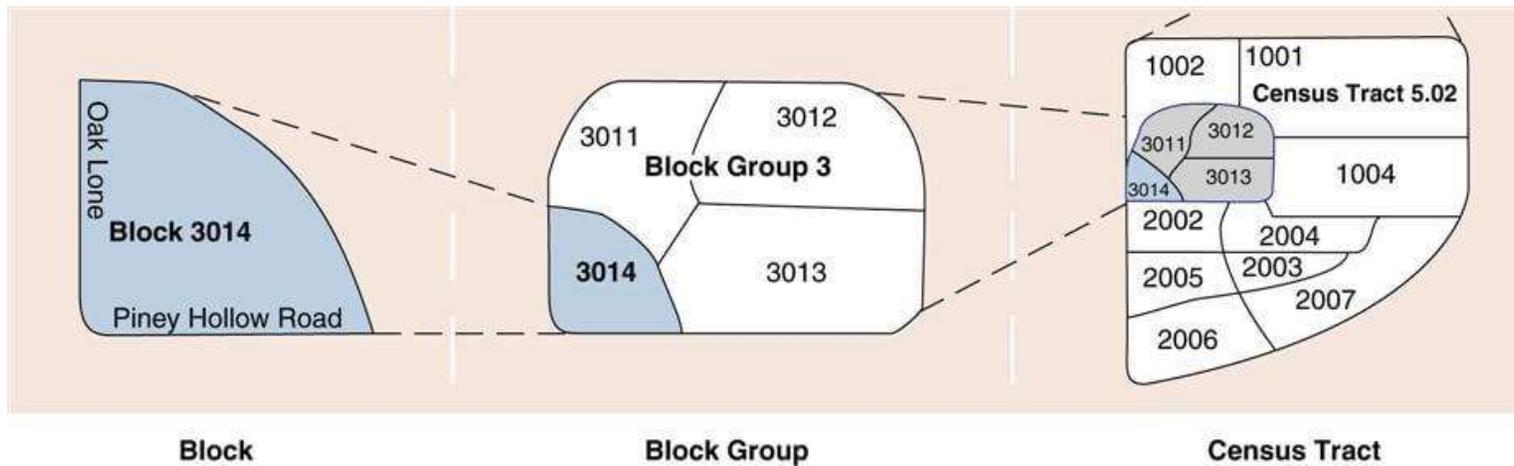
### 2020 Census

- 100% data
- How many people live in the U.S?
- Point in time: April 1, 2020
- Characteristics: Demographic, and some Housing

### ACS

- Sample data
- How do people live in the U.S?
- Period in time: 1 yr, 5 yr
- Characteristics: Demographic, Social, Economic, and Housing

# Census Geography: How it Fits Together

## Demographic Tool

- Compares ZIP Code Tabulation Areas (ZCTA's) within Ameren Illinois service area
- User composes criteria for priority by weighting demographic factors
- Priority is conveyed on a scale from Low Priority (Yellow) to High Priority (Blue)
- Basic information and demographic makeup of ZCTA is viewable when user clicks

## Demographic Data

- Diverse population (Hispanic or non-white)
- Income qualified families (below 300% of federal poverty line)
- Income qualified seniors
- People with less than a high school diploma
- People with a disability
- Renters
- Seniors
- People who are unemployed
- Veterans

## Leveraging CCRPC Data

- Utilized program data and census data provided by CCRPC to identify areas in need of additional MDI partners
  - Two Rivers - Quincy
  - Decatur CAA – Decatur
  
- Utilized a data driven approach to select Peoria as a focus area for workforce development pilot launch
  - Overlaid census information (unemployment, IQ households) with employers, training providers, and community-based organizations

## Leveraging CCRPC Data

- Portfolio Staff target high need zip codes for Program outreach utilizing the CCRPC mapping tool
- Focusing new initiative and pilot efforts
  - 100% of Small Business Energy Performance Pilot participants located in high need areas identified by CCRPC
  - Healthy Homes Pilots focusing project targeting in these areas
- Utilizing available resources within priority zip codes
  - Engaging local organizations to drive customer awareness and Program participation
  - Providing ad hoc copay grants for community-serving institutions and diverse-owned businesses to enable Program participation

## Environmental Justice Overview

- EO 12898 (1994) – Federal Actions to Address Environmental Justice in Minority Populations and Low-Income Populations
  - Identifying and addressing disproportionate effects to human and environmental health felt by minority and low-income populations
- EO 14008 (2021) - Tackling the Climate Crisis at Home and Abroad
  - Establish White House Environmental Justice Interagency Council
  - Develop strategy to address env. injustice
  - Develop clear performance metrics and publish an annual public performance scorecard.

- ID communities to deliver benefits of federal investments as part of Justice40 Initiative

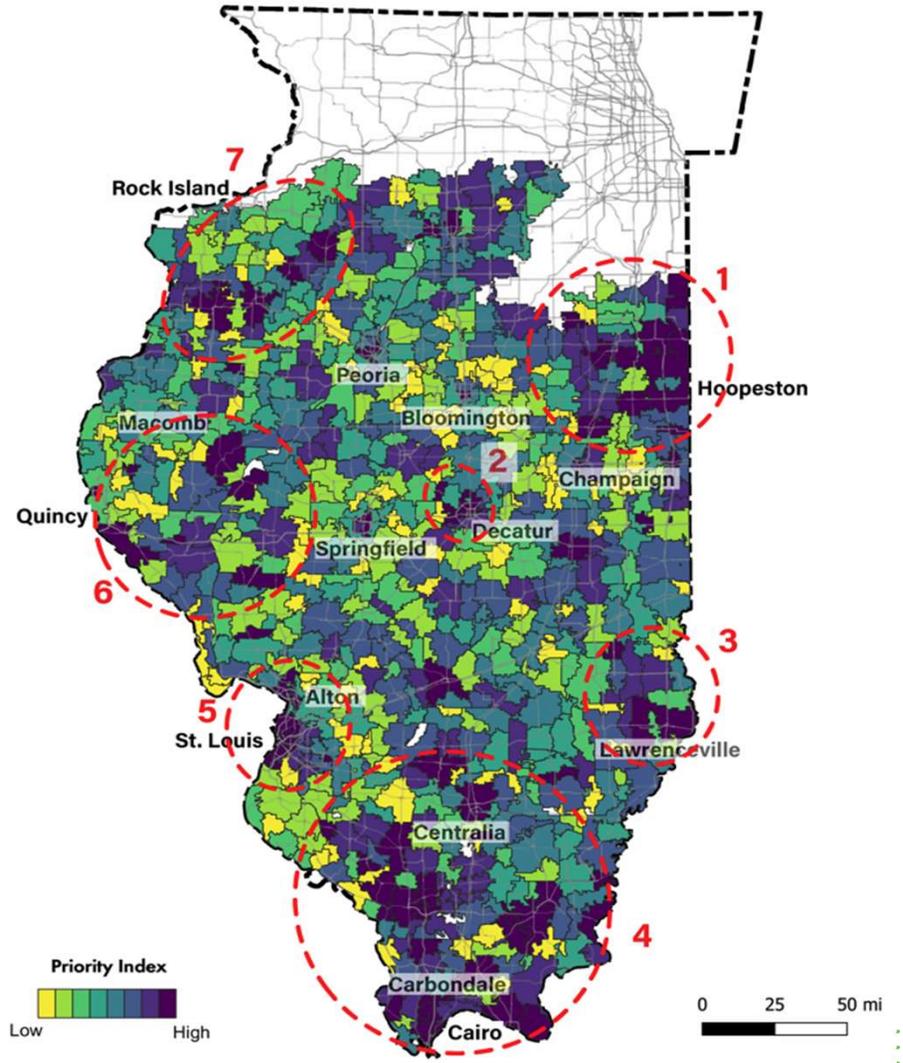

## EJ Missing Socioeconomic Indicators

- **Linguistic Isolation**: Percent of households where no one over the age 14 speaks English well.
- **Poverty**: Percent of a census tract's population in households where the household income is at or below 100% of the Federal poverty level
- **Median home value**: Median home value of owner-occupied housing units in the census tract.
- **Housing cost burden**: Percent of households in a census tract that are both earning less than 80% of HUD Area Median Family Income by county and are spending more than 30% of their income on housing costs.
- **Low life expectancy**: Average number of years of life a person who has attained a given age can expect to live.
- **Higher Education non-enrollment**: Percent of people 15 or older who are not currently enrolled in college, university, or graduate school.
- **Supplemental Nutrition Assistance Program (SNAP) households**
- **Children eligible for free or reduced-price meal program**

# Environmental Indicators of Interest

- **Expected building loss rate**: Percent of building value at risk from losses due to fourteen types of natural hazards that have some link to climate change:
  - Energy efficient buildings are necessary as their use will increase in areas in high building loss rates, and better energy efficiency could reduce vulnerability to certain natural hazards like cold and heat waves
- **Expected population loss rate**: Rate relative to the population of fatalities and injuries due to fourteen types of natural hazards each year that have some link to climate change:
  - Energy efficient buildings can work to limit population loss by giving a respite from cold, heat.
- **Energy Burden**: Average annual energy cost per household (\$) divided by average household income.
  - More energy efficiency = lower energy burden
- **PM2.5 in the air**: Fine inhalable particles, with diameters that are generally 2.5 micrometers and smaller.
- **Asthma**
- **Diabetes**: diabetes other than diabetes during pregnancy.
- **Heart Disease**: angina or coronary heart disease.

# EPA EJSCREEN



- Mapping and screening tool that provides EPA with a nationally consistent dataset and approach for combining environmental and demographic indicators

Allows users to access high-resolution environmental and demographic information for locations in the United States and compare their selected locations to the rest of the state, EPA region, or the nation.
