Re:	Preliminary Evaluation Findings for 2018 Nicor Gas Portfolio		

INTRODUCTION

This memo presents the preliminary results of the impact evaluation of the Nicor Gas 2018 Energy Efficiency Programs. As described in the Illinois Policy Manual,¹ "If draft EM&V reports are not provided by March 15, Evaluators will provide a preliminary evaluation findings memo, including savings and NTG, on or before March 15, utilizing best efforts." Draft reports have been produced for some but not all Nicor Gas programs. Table 1 provides preliminary evaluation findings for all programs in the 2018 Nicor Gas Energy Efficiency Program portfolio. Where savings are indicated as "Draft Internal Findings" we caution that savings could change substantially as the analysis proceeds to draft for external distribution.

Net-to-Gross (NTG) research is currently on-going with 2018 participants of the Multi-Family (market rate) Program, the Business Energy Efficiency Rebate Program including a separate research study targeting steam trap users and trade allies, and Non-Residential New Construction. Draft results of the NTG findings are expected in June and July, with final values established by August 1, 2019.
