#### **Process Item Consensus**



- Interactive Effects
  - Incorporated in all individual, prescriptive measures.
- Organizational Structure of TRM
  - Market, End Use, Technology
- Program Design
  - Measure characterizations are program neutral, but provide specific inputs for different, existing programs.
- TRM Update Procedure
  - Geared to existing regulatory process

- Commercial
  - Boiler Tune Up
  - Steam Trap Repair
  - VSD for HVAC
  - Tankless Water Heaters
- Residential
  - Clothes Washer

## Variable Input Value Categories



- Algorithm Specific Inputs
- Baseline, Lifetime, Persistence, Operating Hours, Loadshape
- Cost Specification
- Weather Data

  - 1. Central AC
  - 2. Aerators & Showerheads
