






- No Budget Flexibility provision was triggered as outlined by the ICC

- MF experienced an uptick due to property owners with larger portfolios & the program is forecasting to complete 266% more in Q4 than Q1-Q3
- Completed Wasted Energy Study for Behavior Program






Business Highlights PY4 Q3
