To all interested parties:

The Illinois NTG Working Group has completed the compilation of comments on Draft 2 of the *Illinois Statewide Net-to-Gross Methodologies* document (IL-TRM\_Attach A\_IL-NTG Methods\_01\_15\_16\_DRAFT2). The Working Group has also largely completed response to those comments and revisions to the Methods document. The following parties submitted comments:

Overall, comments were largely of editorial nature, seeking clarification or pointing out inconsistencies. A few comments from within the workgroup pointed out inadvertent errors introduced in the Draft 2 version of the document. In our judgment, no substantive comments were submitted that would require clarifying discussions with the commenter or deliberation within the SAG.

Embedded in this memo (next page) are three documents:

- IL-TRM\_Attach A\_IL-NTG Methods\_o1\_29\_16\_DRAFT3: The updated IL-NTG Methods Document, incorporating revisions made by the Illinois NTG Working Group in response to stakeholder feedback.
- IL-TRM\_Attach A\_IL-NTG Methods\_01\_29\_16\_DRAFT3-Tracked: A redlined version of Draft 3, that tracks all changes relative to the Draft 2 version from 1/15/2016.
- Summary of Stakeholder Comments 2016-01-29.xlsx: This spreadsheet itemizes all comments and provides a response, where necessary. Note that page numbers in column B refer to the original Draft 2 version of the document. The final column provides the status of each comment/comment response. It should be noted that a few items are still under discussion within the workgroup. These items are marked as "Assigned" or "Workgroup to ok".

Given the lack of substantive changes to the Draft 2 version of the Document, <u>the NTG Working Group</u> suggests that the SAG meeting currently scheduled for Monday 2/1 is not necessary. However, the group is happy to meet for discussion if there are questions related to the changes in this draft.

In addition, we ask that stakeholders (in particular program administrators) conduct a final review of Tables 3-1 and 4-1 in the NTG Attachment.
